thanks for your time yesterday and the opportunity to discuss your initial views on the Department's response to the request of the NOPSEMA CEO of 28 February 2020.

As mentioned, we are working towards a decision within the statutory deadline and work within the availability of the decision-maker.

It would be greatly appreciated if we are able to be in receipt of the Department's reply to the NOSPEMA request by Wednesday (tomorrow) lunchtime at the latest.

Although after the requested date of 9 March, I anticipate we can still remain within the statutory timeframe for making a decision if we can have the formal feedback by Wednesday. This would be on the basis that as per the phone call, the Department is broadly supportive of the approach outlined by WEL in the OPP (extract provided on 28 Feb) being consistent with the relevant requirements under the EPBC Act.

Can you please let me know if the views of the Department alter substantially from the conclusions reached from the initial discussion yesterday, or if the timing is not achievable, as either of these would impact on our ability to meet statutory timeframes.
