As discussed I put some words down yesterday as below

In regards to your view that the aforementioned position does not constitute conditions equivalent, I would like to add that while Laminaria and Corallina are in production under approved regulatory documents, I am advised that these documents do not currently contemplate, nor provide for the relocation of the Northern Endeavour within Australia's jurisdiction. As you would be aware, operations and works in the Commonwealth offshore area must be conducted in accordance with in force permissioning documents that apply to the activity. Should relocation of the Northern Endeavour facility be contemplated, revisions of applicable permissioning documents would require submission and acceptance by the National Offshore Petroleum Safety and Environmental Management Authority. Further, in considering whether or not to support any relocation of the Northern Endeavour facility, the Australian Government would have to closely scrutinise the potential consequences of a relocation from a resource management perspective to ensure that the sovereign rights of Australia with respect to the resources in the Laminaria and Corallina fields are appropriately protected.
